General information:

1. The persons retired from Central Govt./State Govt./Autonomous Bodies/ Central & State Universities (**excluding PSU**), who had been drawing the Grade Pay from **Rs.4600/- to Rs.7600/- (Level-07 to Level-12 as per 7th CPC)** on substantive post at the time of retirement, are eligible for engagement as Consultants on contractual basis. The person should not have attained the age of 63 years as on the last date of application.
2. The candidate should be holding a Degree from any University / Institution recognized / approved by the Central / State Government with atleast 10 years of regular service at supervisory level possessing experience in the field of administration, establishment and legal issues in Central Govt./State Govt./Autonomous Bodies/ Central & State Universities (**excluding PSU**).
3. Initial engagement of Consultant will be for six months, with the possibility of extension based on performance and need. The engagement of Consultant is purely temporary in nature.
4. The work and conduct of the Consultant shall be reviewed by the Director, NITTTR Chennai from time-to-time. In case his/her performance is not found satisfactory, his/her temporary engagement is liable to be terminated without assigning any reasons.
5. The engagement is liable to be terminated by either side with notice of not less than 30 days. The Institute, however, reserves the right to terminate the engagement without notice by paying remuneration in lieu thereof.
6. Consultant will not be entitled for any benefit / compensation / absorption / regularization of service in the Institute / Ministry.
7. The Consultant shall not divulge any information, gathered by him / her during the period of the assignment to anyone who is not authorized to know / have the same.
8. The engagement as consultant shall not be considered as a case of re-employment.
9. The job involves travel to its extension centres located at Bengaluru, Hyderabad, Kalamasery, Vijayawada and also to MoE, New Delhi.
10. The appointment of Consultant would be on full-time basis and he/she will not be permitted to take up any other assignment during the period of Consultancy with NITTTR, Chennai.
11. No TA/DA will be paid for attending the interview.

Terms and Conditions

Some of the salient terms and conditions are given below:-

1. **Allowances:** The Consultant shall not be entitled to any allowances such as DA, HRA, Transport allowance, Medical reimbursement or any other benefits etc. however, if he/she is required to travel within the country on official work, TA/DA as admissible to the grade from which he/she retired will be payable only based on the approval of the Director.
2. **Leave:** Consultant shall be entitled for 8 days leave in a calendar year with prior approval. No remuneration for the period of absence in excess of the admissible leave will be paid to him / her. Un-availed leave shall neither be carried forward to next year nor encashed. Duties performed on Saturday, Sunday or any holiday will not be compensated by grant of Compensatory Holiday.
