The Board of Governors noted the action taken by the Institute on the resolutions passed in the  $40^{\text{th}}$  meeting held on 04.10.2019 and directed the Institute that the action taken report should be placed in the tabular form with supporting Annexures. Item No.3:

The Committee went through the Judgment & Legal Opinion and directed the Institute to go for an appeal against the judgment of a single judge, as per the legal opinion.

Item No.4:

To consider and approve the declaration of probation in respect of Dr. E.S.M. Suresh, Professor & Head, Department of Civil & Environmental Engg., based on the direction of the 40<sup>th</sup> BOG meeting held on 04-10-2019.

As per the aforementioned Item No. 4 of 41<sup>st</sup> BOG meeting held on 07.01.2020 in Shastri Bhawan, New Delhi, the BOG Members went through the entire proposal including all the relevant annexures. In accordance with the directions of the 40<sup>th</sup> BoG meeting held on 04.10.19, the Member-Secretary has taken a legal opinion from Shri. Su. Srinivasan (Former Assistant Solicitor General of India, Senior Central Government Standing Counsel, CAT, High Court of Madras) and same was communicated to the Performance Assessment Committee (PAC) Members. Also a meeting with the same PAC Members was arranged during the 41st BOG meeting at New Delhi. Due to preoccupations of PAC Members, they could not attend the meeting physically. However, all of them have given their written opinion to clear the probation of Dr. E.S.M. Suresh, Professor & Head, Department of Civil & Environmental Engineering, NITTTR, Chennai. In addition to this, live opinion through Skype from the two external PAC members (1. Prof. S.K. Ghosh, IIT, Roorkee and 2. Prof. G. Ramakrishna, Pondicherry Engineering College, Puduchery) have given their opinion to clear the probation of Dr. E.S.M. Suresh, Professor & Head, Department of Civil & Environmental Engineering, NITTTR, Chennai.

Based on all the documents mentioned in Agenda Item No. 4 of 41<sup>st</sup> BOG meeting and written/live opinions of PAC Members, the Board unanimously approved to clear the probation of Dr. E.S.M. Suresh, Professor & Head, Department of Civil & Environmental Engineering, NITTTR, Chennai followed by confirmation.

Item No.5:

To seek direction from the Board for filling vacant positions of Associate Professors & Professors in lieu of recent AICTE Gazette Notification, dated 1<sup>st</sup> March,2019.

The Board discussed this item and directed the Member Secretary to follow the MOA Rules and Regulations of NITTTR Chennai keeping in view of the essential qualification and experiences of AICTE norms as may be vogue from time to time. In order to avoid miss-match in the implementation of Roster system for the direct recruitment of faculty positions as per the Central Educational Institutions (Reservation in teachers' Cadre) Act, 2019 vide MHRD Lr.F.No.4-1/2019-TS. IV(Vol.5) dated 18-11-2019, the lower posts cannot be treated as vacant in the event of CAS promotions. Item No.6:

To consider and decide on the issue relating to the probation clearance of Dr. G. Janardhanan

The BoG Members went through the entire proposal including all the relevant annexures. On scrutiny of the verification report of Commissioner of Police, Greater Chennai, related to character & antecedent (Rc.No. G2(2)/320/102981/2018 dt. 02.11.2018) of Dr. G. Janardhanan, it is very clear that there is no adverse remarks against him. Also the advance raised towards conducting training courses is settled by 31<sup>st</sup> March 2012 as certified by the Accountant of NITTTR Chennai towards settlement of accounts. In addition, Five-Member Committee report and opinion from Shri. Su. Srinivasan (Former Assistant Solicitor General of India, Senior Central Government Standing Counsel, CAT, High Court of Madras) was taken into consideration.

In view of this, the Board unanimously approved to clear the probation of Dr. G. Janardhanan, Associate Professor, Department of Civil and Environmental Engineering followed by confirmation without referring to any other Committee, as the academic performance assessment was carried by the Director and concerned Head of Department on 13<sup>th</sup> September 2019.

In this connection, a series of Mentors Training Programme (MTP) will be conducted in southern region and the cost involved may kindly met from the operational fund under Head 31.
