This report reflects the accomplishments made in the areas of technical teachers training (for Polytechnics / Engineering colleges), research, curriculum development, overseas training programmes and industry collaboration along with other similar activities by the dedications of our faculty members. This report also

incorporates the Vision, Mission and Objectives of the Institute and its functions, co-ordination with State, National and Regional level bodies and activities undertaken by the Institute under various National Schemes.

We are always striving to take advantage of technological developments that can make our training programmes more effective and accessible to our teachers nationwide. We recognize that not all the faculty members have the same access to technology, so we are careful to integrate the latest technological developments into our training, without making our training inaccessible or unaffordable for anyone. The continuous upgradation of laboratory and instructional facilities assure the participants a rewarding learning experience and change in environment. The year 2016-17 represented another period of expansion and developmental activities of the institute. During this year the following were achieved:

- Training of 2625 technical teachers from 131 courses for polytechnics and 1593 technical teachers from 233 courses for engineering colleges.
- Training of 163 teachers, policy makers and educational administrators from 44 countries through 8 Overseas Trainees Courses
- Doctoral degree in Engineering Education awarded to 11 candidates. 23 candidates are currently pursuing Ph.D.
- Curricula of 35 programmes consisting of 250 courses were revised.
- Development of 50 instructional resources (print type materials and videos)

Although we train many tens of thousands of individuals worldwide, perhaps the most gratifying part of our work at NITTTR, Chennai is when we hear directly from participants their experience / feedback of staying in NITTTR, Chennai campus. They participate in discussions and suggest improvements in all aspects and based on which we set our commitment and broad vision in our future programmes.

1.0 PREAMBLE

he National Institute of Technical Teachers Training and Research (NITTTR) Chennai was established as an autonomous Institute by the Ministry of Human Resource Development, Government of India in the year 1964 to improve the quality of Technical Education System in India and in the Southern Region in particular. Within this mandate, the institute takes initiatives to offer need based Human Resource Development programmes through appropriate modes and develop curricula and instructional resources. It also fosters research in the core engineering area and also in the inter-disciplinary area of Engineering Education and offers consultancy services for the total development of Engineering Colleges, Polytechnics, Vocational institutions, Industry, Service sector and the Community at large.

In carrying out the above mandate, the institute collaborates with national and international institutes, universities and other agencies interested in and / or deriving benefits from technical education and training.

The NITTTR, Chennai envisions to be a leading institute in promoting excellence in Technical Education Systems by planning, designing, developing, implementing and evaluating quality training programmes, learning resources, research and consultancy projects for technical educational institutions, industry and community.

2.0 OBJECTIVES


The objectives of the institute are:

- ✓ To undertake systemic research to provide inputs for development of technical education training systems and their management.
- ✓ To undertake and guide research for development of innovative methods, processes and practices for improvement of teaching-learning environment in technical institutions.

- ✓ To design new instructional systems and strategies for production of multimedia learning materials.
- ✓ To develop and disseminate learning resources like textbooks, laboratory manuals, video programmes, computer assisted instructional multimedia packages to technical institutions and other organisations.
- ✓ To offer programmes for technical teachers in distance learning mode using state-of-the-art technologies.

During the year 2016-2017, the institute undertook programmes, projects and activities under four major areas namely: (i) Faculty Development, (ii) Curriculum Development, (iii) Instructional Resources Development, and (iv) Research and Consultancy Projects.




The institute focused on the following activities during the year 2016-2017:

- Training of teachers of Engineering Colleges, Polytechnics and personnel from industry and professionals through short-term courses in areas like Engineering and Technology, Instructional Design and Delivery, Educational Technology, Accreditation, Human Resource Development, Curriculum Development and Entrepreneurship Development.
- 2. Conducting seminars/symposium/workshops for professional development of teachers.
- 3. Developing research capabilities in teachers of engineering colleges, polytechnics and personnel from industries through inter-disciplinary research leading to Ph.D.
- 4. Training of teachers of Engineering colleges, Polytechnics and others through long-term programmes like M.Tech. (HRD).
- 5. Providing expertise to overseas participants through specially designed training programmes.
- 6. Developing curricula for education and training programmes and revising the curricula of existing programmes.
- 7. Developing/revising instructional resources (materials and media) needed for effective implementation of polytechnic and engineering college curricula.
- 8. Undertaking research and development projects relevant to technical education system.
- 9. Developing e-content on teacher education under SWAYAM platform.
- 10. Providing consultancy services for the effective implementation and monitoring of the following schemes / projects:
 - a. Scheme of Community Development through Polytechnics
 - b. Sub-Mission on Polytechnics
 - Upgrading Infrastructure of Existing Polytechnics
 - c. Project for Persons with Disabilities
 - d. Expert committee visit to facilitate accreditation
 - e. Technical and consultancy service in the area of engineering / technology

f. Need based human resource development programmes and projects for industries, govt. departments and service organizations

4.0 FACULTY DEVELOPMENT PROGRAMMES

Faculty development programmes for teachers of engineering colleges and polytechnics is a priority area of the institute. In recognition of this, the institute planned and conducted a variety of short-term and long-term training programmes for teachers and staff of the polytechnics, engineering colleges as well as teachers from overseas to enable them to acquire competencies relevant to their respective areas of work.



4.1 LONG-TERM TRAINING PROGRAMMES

a) DOCTORAL RESEARCH PROGRAMME

The institute continued to vigorously promote educational research programmes and encourage technical teachers, working personnel from industries and other education sectors to undertake research work in the areas of Engineering Education (Inter-disciplinary). The institute is a recognized doctoral research centre by the University of Madras and Anna University, Chennai.

So far a total number of 81 scholars have been awarded Ph.D. degree in Engineering Education under University of Madras. As on date, 23 candidates are pursuing Ph.D. in this Institute. During this year, eleven scholars were awarded and three enrolled in Ph.D. in Engineering Education by the University of Madras as detailed in Table 1.

b) M.Tech. (Human Resource Development) PROGRAMME

This master's programme in Human Resource Development (HRD) of four semesters aims to produce competent human resources for the technical education sector. The programme of study comprises of 13 core courses, a dissertation (equivalent to two courses), seven electives, two soft skills courses and an internship.

This programme includes core subjects: Principles of Management, Organizational Behaviour, Industrial Sociology, Industrial Psychology, Research Methodology in HRD, Information and Communication Technology for HRD, Organizational Development, Legal Aspects of Human Resource Management, Human Resource Management, Soft Skills 1 & 2, Human Resource Development, International Human Resource Management, Training and Development, and Financial Management. Students have been provided with several elective subjects namely: Institutional Evaluation and Development, Management Information System, Planning and Production of Video Programmes for HRD, Project Management, Marketing Management, Enterprise Resource Planning, Performance Management, Knowledge Management, and Total Quality Management. An Internship has been included as a compulsory requirement and is to be carried out in the summer vacation after the second semester.

During this year, X Batch consisting of four candidates completed M. Tech (HRD) programme.

c) OVERSEAS TRAINING COURSES (OTC)

During the year 2016-17, the institute organized eight training programmes for the overseas participants under the ITEC (Indian Technical & Economic Cooperation)

and SCAAP (Special Commonwealth African Assistance Programme) schemes. They are fully-funded by the Ministry of External Affairs, Government of India, for training civilians from 161 countries in Asia, East Europe (including former USSR), Central Asia, Africa, and Latin America, the Caribbean as



well as Pacific and Small Island countries. As a result, NITTTR Chennai is actively involved in conducting specially designed training programmes under ITEC and SCAAP schemes for the past 35 years and there is now a great visibility and growing awareness among other countries about the competence and service provided by NITTTR Chennai. Over the years, the Technical and Economic assistance programme of the

Ministry of External Affairs, Govt. of India has generated immense goodwill and substantive cooperation

among the developing countries of the world. The Centre for International Affairs carries out the overall management of the programmes, with the respective coordinators taking care of the academic aspects. The details of OTC programme are presented in Table 2 & 3.

4.2 SHORT-TERM TRAINING PROGRAMMES

a) POLYTECHNIC COLLEGE PROGRAMMES

The institute continued to implement the Government of India's scheme of Quality Improvement Programme (QIP). The main objective of the scheme is to improve the competencies of a large number of technical teachers in a relatively short-period through short-term staff development courses of one to two weeks duration. Recognizing the need for technical teachers and other staffs to enrich their knowledge and to keep themselves abreast with the latest technologies, the institute organised training courses of duration


varying between one and two weeks. These training courses are continuously reviewed, modified and redesigned so that the ever expanding and changing needs of teachers are met.

The specific training need of the teachers of the polytechnics in each of the southern states were identified through need analysis survey carried out by our Extension Centres and the State Directorates. The course details, duration and venue were finalized in Programme Development Committee meetings held on 28.02.2016, attended by the representatives of Directorates of Technical Education. These meetings ensured that the courses planned, designed and conducted will cater the training needs of teachers. These staff development courses were organized at the Institute Headquarter in Chennai and its Extension Centres located at Hyderabad, Vijayawada, Bengaluru and Kalamaserry. The participation of experts from industries and institutions of reputes such as IITs and CSIR Laboratories enriched the effectiveness of the training courses. Industrial visits formed an integral component of majority of the training courses.

During this year the courses were conducted covering the following broad areas:

- Content updating in Engineering and Technology
- Instructional Design and Delivery System (Basic and Advanced Pedagogy)
- Evaluation of Students Performance
- ▶ Instructional Content Development for Electronic Media
- ▶ Use of free and open source softwares
- ► ICT Tools for Teachers
- Guidance and Counselling
- Life Skills
- Curriculum Revision for Diploma Programmes.
- ▶ NBA Accreditation Procedures and Outcome Based Education

The performance in the aforementioned areas during the year under report had been impressive as 131 courses were conducted involving a total of 2625 participants (Male: 1764, Female: 861) from the polytechnics (Table 4). Thus till date 74,049 technical teachers from polytechnic system have been trained through 3925 courses.





6.0 CURRICULUM DEVELOPMENT

Curriculum Development Centre of the institute was set up in 1970 for revising curricula of existing programmes and developing curricula for new programmes of polytechnics to meet the ever-changing technical human resource needs of the expanding Indian economy. The institute has evolved a curriculum development model which includes job and task analysis for developing technician profiles, identifying technician competency, formulating learning outcomes reflecting the knowledge, skills and attitudes, clustering and sequencing contents, and designing suitable evaluation schemes. The relevance and appropriateness of the curricula are ensured by the involvement of polytechnic teachers, industrial representatives and faculty from institutions of higher learning and the officials of the Directorates of Technical Education at all stages of curriculum development. During 2016-17, Curricula for 35 programmes consisting of 250 courses were revised for the polytechnics of Karnataka state.

7.0 INSTRUCTIONAL MATERIALS DEVELOPMENT

During 2016-17, the institute has updated the 23 course materials in various Engineering subjects, and Pedagogy for use by teachers of technical institutions.

8.0 INSTRUCTIONAL MEDIA DEVELOPMENT

Video programmes

The institute has developed, over the years excellent facilities for the production of Educational Video Programmes in the technical education and teacher training. During the year under report 27 video programmes were produced for teachers and students of technical education institutions.

10.0 SWAYAM PROJECT

The NITTTR, Chennai has been identified as the National Coordinator on 5th October 2016 to offer Massive Open Online Courses (MOOCs) on teacher



training for the portal called Study Webs of Active-Learning for Young Aspiring Minds (SWAYAM). SWAYAM has been developed under a four-quadrant approach using audio-video methods, e-books, illustrations, text, case studies, research papers, and self-assessment. A one-day Workshop on Teacher Training MOOCs was orgainsed at NITTTR, Chennai on December 14, 2016. Twenty two delegates from four NITTTRs attended the workshop. Since there is no dedicated syllabus for developing technical teacher education programmes, in the country, a detailed deliberation was carried out and 50 courses were finalized under five major sectors namely (a) Fundamentals of Teaching and Learning (b) Technology Enabled Teaching (c) Media and Information literacy (d) Professional Development, and (e) Institutional Development.

An Inter-NITTTR two-days workshop on January 30th and 31st, 2017 was organized at NITTTR Bhopal to finalize the course content for each subject and develop policy paper for delivering the courses. 47 delegates from four NITTTRs attended the meeting.

11.0 SCHEME OF COMMUNITY DEVELOPMENT THROUGH POLYTECHNICS

As a Direct Central Assistance Scheme, the scheme of Community Development Through Polytechnics (CDTP) sponsored by MHRD, Govt. of India, New Delhi is being implemented in 190 polytechnics in the Southern Region as on date.

Role of NITTTR

To enable the project personnel associated with the implementation of CDTP scheme in their respective polytechnics, the Centre for Rural Development (CRD) of the institute serves as a resource centre. It conducts orientation training programmes, State-wise workshops, annual review of the scheme and other subject related short-courses regularly. Besides, the CRD assists the MHRD in preparation of various Progress Reports and the expenditure related matters.

During the Year 2016-17, the operational plan proposals for the scheme of CDTP submitted by the polytechnics in the southern region were scrutinized and were approved. The Physical Achievement Reports (PAR) for the year 2015-16 submitted by the polytechnics were compiled and forwarded to the Ministry.

12.0 INTEGRATING PERSONS WITH DISABILITIES INTO THE MAIN STREAM OF TECHNICAL AND VOCATIONAL EDUCATION

In accordance with the Persons with Disabilities Act – 1995 and the National Policy of Education (1986), the Ministry of Human Resource Development, Govt. of India has launched a Centrally Sponsored Scheme for upgrading selected polytechnics in the country to integrate Persons with Disabilities (PWDs) into the main stream of technical and vocational education.

Objectives of the Scheme

- Promote education and training of PWDs in the main stream of technical and vocational education and skill development programmes through formal and non-formal Programme.
- Identify PWDs in the suitable geographic catchments of the polytechnics.
- Identify suitable education and training programmes for PWDs with special emphasis on formal skill development programmes for illiterate youth with disabilities, for promoting wage or self employment as far as possible at their place or residence.
- Design need and competence based curricula for PWDs
- Preparing / procuring / developing suitable resources, including physical, human and informational for effective implementation of the programme.
- Develop norms and standards for different phases of the scheme, wherever needed.
- Network and collaborate with resource institutions and other organizations and take their assistance for manpower training, guidance and effective implementation of the scheme.
- Sensitize administrators, planners, faculty, staff and students and community at large about the problems and capabilities of the students with disabilities and to create suitable environment in the polytechnics.
- Develop innovative educational technologies and approaches for education, training and rehabilitation of youth with disabilities.
- Strengthen the existing placement cells of polytechnics to help for providing guidance and counseling and placement of youth with disabilities for wage and self employment opportunities.
- Evolve suitable methods and practices for monitoring the scheme.

REPORT ON ACCOUNTS 2016-17

As Audited by the PRINCIPAL DIRECTOR OF AUDIT (CENTRAL) CHENNAI

Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the National Institute of Technical Teachers Training and Research, Chennai for the year ended 31 March 2017

We have audited the attached Balance Sheet of the National Institute of Technical Teachers' Training and Research, Chennai as at 31 March 2017, Income & Expenditure Account and Receipts & Payments Account for the year ended on that date under Section 20 (1) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971. The audit has been entrusted for the period up to 2017-2018. These financial statements are the responsibility of the Institute's management. Our responsibility is to express an opinion on these financial statements based on our audit.

- This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any are reported through Inspection Report/CAG's Audit Reports separately.
- We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.
- 4 Based on our audit, we report that:
 - We have obtained all the information and explanations (except mentioned in comment No C-4 to C-7 and Annexure 2 (iii)), which to the best of our knowledge and belief were necessary for the purpose of our audit.
 - ii. The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format approved by Ministry of Human Resource Development.
 - iii. In our opinion, proper books of accounts and other relevant records have been maintained by National Institute of Technical Teachers' Training and Research, Chennai as required in the rules and regulations of the Institute in so far as it appears from our examination of such books.
 - iv We further report that:

A Balance Sheet

1. Schedule 4 - Fixed Assets and Schedule - 8 Current Assets- Loans, Advances and Deposits

As per Annual Accounts, Capital Work in Progress was Rs 12,39,03,685 and Deposits with CPWD was Rs 8,15,74,243 as on 31.3.2017.

Whereas as per Form 65 furnished by CPWD, out of total deposit of Rs 19,67,80,005, Rs 4,02,78,823 was transferred for Electrical work and

Rs 15,91,06,728 was available for Civil Work. Out of Rs 15,91,06,728 available for civil work, Rs 7,71,31,343 had been utilized and unutilised balance was Rs 8,24,35,985. The balances were not reconciled with CPWD.

2. Schedule 3 current liabilities Schedule 3(a) – Sponsored Projects SWAYAM project Rs 4.95 crore and Schedule 8 (7) (a) – Debit balance in Sponsored Projects: SWAYAM project expenses Recoverable – Rs 15,50,409

As per Schedule 3 (a), expenditure incurred for the above project during the year was NIL. However, as per Schedule 8, project expenses (recoverable) was Rs 15,50,409. The difference was not reconciled / rectified.

3. NPS Tier -I Account - Balance at Bank - Rs.51,834

As per the accounts of NPS Tier –I, the balance at bank as at the end of the year was Rs.51,834. Whereas as per the Cash book, the balance was Rs.2,58,296. Eventhough the difference was identified, it was not rectified.

4. Corpus Fund Account - Rs 22,93,817

Corpus Fund was separated from the Main Financial Statement of the Institute. Separate set of Financial Statements viz., Balance Sheet, Income & Expenditure Account and Receipts & Payments account have been prepared for Corpus Fund. This is not in conformity with MHRD format of Accounts, which stipulates that Corpus Fund should be accounted in Schedule 1 A under Schedule 1 - Capital Fund within the Main Financial Statements of the Institute.

5 Schedule 4 - Fixed Assets Rs 23.10 crore

Actual cost of acquisition was not shown under Gross Block. Instead, the written down value of the assets on 1.4.2016 was shown as opening balance of Gross Block and depreciation on Straight Line Method was applied on the above value. Further, as per the disclosure in Point No. 4 of Schedule 24 (Significant Accounting Policy) 'depreciation was calculated as per WDV method' needs to be corrected and depreciation should be charged retrospectively on the original cost of Assets and its impact should be disclosed in Notes on Accounts. Further disclosure made in Schedule 24 should be revised accordingly (i.e) Depreciation was provided on the basis of Straight Line Method.

6. Fixed Deposits - GPF Account - Rs 3,71,49,110 and OTC Account-Rs 6,32,00,000

Difference between figures accounted under Fixed deposits in respect of GPF and OTC accounts in the annual accounts and as per the certificates produced to audit were as follows:

These needs to be reconciled.

B General

- Provision for retirement benefits had not been made on actuarial valuation basis as stipulated in Accounting Standards 15.
- 2. Closing Balance as per Receipts & Payments Account had not been segregated as Balance in Deposit Account and balance in Savings / Current Account in respect of

Project, OTC and Grant Accounts. Instead, they have been clubbed and exhibited as a single figure.

- 3. Cash Book was not maintained for Rajiv Gandhi Fellowship Scheme Account, Statutory payment Account and Tamil Nadu State Apex Co-op Bank Ltd-Athletic Account.
- 4. Though the accrued interest on deposits in respect of GPF and OTC Accounts have been accounted in the revised accounts, disclosure was not changed accordingly in Schedule- 24 Significant Accounting Policies.

C Effect of Revision in Accounts

Based on audit observations, accounts of National Institute of Technical Teachers' Training and Research, Chennai were revised. As a result of revision, Assets and Liabilities were increased by Rs.1.16 crore and deficit decreased by Rs 0.85 crore.

D Grants-in-aid

Out of the Grants-in-aid of Rs 26.26 crore received for the year 2016-17 and Rs 15.93 crore being unspent balance of the previous year, the Institute could utilize Rs 22.65 crore leaving a balance of Rs 19.54 crore as unutilized grant as on 31st March 2017.

- v. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report are in agreement with the books of accounts.
- vi In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in Annexure to this Audit Report give a true and fair view in conformity with accounting principles generally accepted in India.
- a. In so far as it relates to the Balance Sheet, of the state of affairs of National Institute of Technical Teachers' Training and Research, Chennai as at 31 March 2017; and
- b. In so far as it relates to Income & Expenditure Account, of the deficit for the year ended on that date.
