The undersigned is directed to say that it is proposed to dispose of a condemned Van being Registration Number KRF-3902, make Matador.



In case you are interested in purchasing the above mentioned vehicle, you may submit your highest quotation in the enclosed Performa. The quotation addressed to the undersigned in a sealed cover should reach **NITTTR, Kalamassery (ECK) office latest by 13/04/2021 at 03.00 PM**. The quotation received in time will be opened at 03.30 PM on the same day. The quotations should be dropped in the Tender Box kept in the office of the "NITTTR, Extension Centre, Kalamassery-683 104". The cover should be superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". **The vehicle will be available for inspection between 10.00 PM to 04.00 PM from 29.03.2021** onwards after seeking an appointment with the Project officer (C) in-charge, NITTTR Extension Centre, Kalamassery-683 104 on Telephone No. 0484-2542653 and Mobile No. 8089921675.

The quotations received in time will be opened at NITTTR, Extension Centre; Kalamassery-683 104. The bidder may send only one representative during opening of quotation.

The sale will be governed by the following conditions:

- i) The bidder is required to pay Earnest Money for Van of Rs.1,000/- (Rupees One thousand only) payable by means of Demand Draft drawn in favour of **"The Director, NITTTR, Chennai."**
- ii) Quotation received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of demand draft drawn in favour of **"The Director, NITTTR, Chennai"** *within two working days* of the acceptance of the bid.

- iv) If it is found that the amount quoted by the successful bidder (highest bidder) is less than the reserve price fixed by the Kerala PWD Mechanical Sub-division, Chalakkudy – 680 307, the bid may be treated as cancelled.
- v) The Earnest Money of the successful bidder will be released only after the deposit of sales proceeding. Earnest Money will be forfeited if he fails to honour the bid.
- vi) The delivery of the sold vehicle will be arranged after the successful bidder submits documentary evidence in support of residential status viz. Ration card/Voter Identity card/ Aadhaar card/ Passport in case of individual and Registration Certificate in case of firms etc.
- vii) The sold vehicle should be removed by the successful bidder **within five working days of depositing the money at their own expenses** after that penalty of Rs.500/- per day will be charged.
- viii) The vehicle will be disposed of in as is where is basis and no guarantee for its worthiness or quality will be given by this office. However they have to remove the parts where engine number and chassis number are recorded and hand it over to NITTTR ECK authorities in order to hand it over to Motor Vehicle Department for the completion of RC book cancellation process.
- ix) The successful bidder will also be responsible for shifting the vehicle without riding through road since its registration is cancelled. The office will not be responsible for any lapse on his part in this regard.
- x) The bidders will not be allowed to withdraw their bids, failing which their Earnest Money will be forfeited.
- xi) The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
